BIP MEDICAL HUMANITIES

Objectives of the BIP:

1. Introduction to Medical Humanities and its application in modern education at medical universities
2. Presenting the benefits from uniting of medicine and art/humanities in favour of better care for people's health
3. Sharing the results and good practices about the implementation of Medical Humanities in the education of medical students
4. Presenting the diverse and rich nature of the content of the Medical Humanities through lectures and workshops

Presentation:

- Humanities share with medicine the focus on people. Medical Humanities unite them and give a unique outlook and idea of human conditions, diseases and sufferings as well as perception of one's own personality, professionalism and responsibilities towards oneself and others (colleagues and patients).
- Born at the end of 20th century, Medical Humanities is a multidisciplinary field integrated into the curriculum of a number of medical universities and colleges around the world. It brings together the humanities (theory of literature and the arts, philosophy, ethics, history and theology), the social sciences (anthropology, psychology and sociology) and the arts (literature, theatre, cinema, music and visual arts).
- Medical Humanities represent an approach through which the arts and humanities can offer more efficient health care than simply improving medical education. It offers different ways of thinking about human history, culture, behavior and experience that can be used to dissect, critique and influence health practices and priorities.
- Medical Humanities can also help medical practitioners consider professional issues from more than one perspective.





MEDICINA GRATIA ARTIS

Medicine, as Hippocrates says, is an ART. An art that connects the patient with his doctor and in this way brings social relations into the world of healing.

The doctor is a mediator between two levels and two "realities", so his role is also dual. Explaining the patient's condition, the doctor performs a double function - by decoding the symbols (symptoms), he:

- 1) connects the world of the hidden/unknown and the real world and
- 2) unites the patient's split personality (as a physical and spiritual entity), thereby resolving the body-soul dichotomy.

In other words, medicine is an art of attitude and humanity, which heals by the knowledge and skills of the doctor. But the art that shapes man as a social creature through communication (word, image, harmony or symbols) can not only heal, yet also change the organism at the cellular level. The human genome changes and develops thanks to art, which helps us both to be healthy and to become better and better (the theory of "gene-cultural co-evolution").

To Medical Humanities goes also the credit of understanding that there are many factors that can assist in the healing process. And these are to be offered by the humanities and arts.





BIP MEDICAL HUMANITIES

Methods and outcomes:

In order to achieve its aims, the BIP will combine lectures, workshops, cultural events and discussions. To share their knowledge and expertise and invited specialists from different European universities working on the field of Medical Humanities as well as members of the AMH (Association for Medical Humanities).

The outcomes are provisioned to be as follows:

- Expanding the volume of existing medical knowledge about processes and phenomena with the help of Medical Humanities
- A basis for introduction/implementation of a new discipline into the training of future medical personnel and this is namely Medical Humanities. Going into the world of art and literature helps develop skills of observation, analytical reasoning and empathy. That is why the introduction of Medical Humanities in the students' programs at different universities will help the general development of students, not just their professional skills.
- Thanks to Medical Humanities the future medical personnel will be able to develop a) their imagination (knowledge of symbols), b) ability to interpret data, c) skills to carefully observe and interpret the "language" of the patient, d) empathize with patients and e) build personal and professional values.
- With the help of Medical Humanities can also be enforced medicosocial research on the correlation between the biological and social functions of man and society; the influence of the main social phenomena and the environment on the human health and diseases as well as research related to optimizing the organization and management of medical science, practice and education.
