

#### European Higher Education Fair 2017 Japan (EHEF 2017)

Study and Research in Europe; Quality-Diversity-Opportunity

It is with great pleasure that the Delegation of the European Union to Japan, along with our coorganisers, the Directorate-General for Education and Culture (European Commission), Campus France, the German Academic Exchange Service (DAAD), and Meiji University, announce the holding of the European Higher Education Fair 2017 Japan (EHEF 2017). This is the sixth EHEF, following on from highly successful events held annually since 2012. The 2016 event saw over 1200 students visit, with nearly 60 institutions from 15 EU Member States exhibiting.





EHEF 2017 will be held in the Kanto and Kansai regions of Japan over a three day period from 19-21 May. The event will open on Friday 19 May with a Networking Event and Welcome Reception for European exhibitors and their Japanese university counterparts at the Delegation of the EU to Japan in Tokyo. The fair will then run at Meiji University (Tokyo) on Saturday 20 May, and at Doshisha University (Kyoto) on Sunday 21 May. Additional efforts to reach out to other regions via social media/live streaming, are also foreseen.

Higher education institutions from Europe, as well as European embassy higher education promotion officers based in Japan are invited to take part in EHEF 2017 to promote study programmes (bachelors, postgraduate, short-term, research) directly to visitors. Application details follow in the attached annexes. #### Annex 1

European Higher Education Fair 2017 Japan (EHEF 2017)
Terms and Conditions

These are the Terms and Conditions for participation in the EHEF 2017, drafted by the Organizing Committee (Delegation of the European Union to Japan, Campus France Japan, DAAD Japan, Meiji University), to be followed by Exhibitor (the eligible institution, network or consortium of institutions, national representation, or their representative, which has made a successful application to the Organizing Committee to participate in EHEF 2017)

#### Booths

Exhibitors will be allocated a booth as detailed in the application form. Exhibitors will accept the booth that is allocated to them by the Organizing Committee. Exhibitors must not change the booth structure, fascia board, or any other element that is common to all booths without prior approval from the Organizing Committee. Depending on the location of the booth area, specific locations may have electrical boxes and cables running through or beside the booth.

#### Payment schedule

Campus France Japan, on behalf of the Organizing Committee, will invoice Exhibitors for the Fair booth once participation has been approved by the Organizing Committee. Participation will only be confirmed when this fee is received. The terms of the payment are stated on the application form and must be respected in order for the Exhibitor to be able to take part in the Fair. The Organizing Committee reserves the right to cancel the contract and otherwise dispose of the space reserved if payments are not remitted on time. In such an event, the Organizing Committee shall not be liable for any resulting costs, damage and/or losses charged to the Exhibitor.

German institutions participating in the Fair will make their payment directly to DAAD/GATE, which will transfer the respective payments to Campus France Japan.

If, on the instructions of the Exhibitor, invoices are made out to a third party, the Exhibitor continues to be liable for all charges.

#### Accommodation, travel and freight

Please note that the Exhibitor fee does not include accommodation, subsistence, visas, insurance, freight charges or international or domestic travel costs or other ancillary costs arising out of participation in EHEF 2017.

## Promotional materials and displays

Exhibitors are NOT allowed to distribute literature or materials or any promotional items of any sort outside of their booth, either inside or outside the Fair exhibition area. Distribution of materials at relevant presentation sessions is permitted. Exhibitors may be asked to submit all promotional items, materials, literature and displays to the Organizing Committee for approval and to make such changes as shall be agreed. If agreement cannot be reached, the Exhibitor must withdraw the literature, material or display. The Organizing Committee reserves the right to close down any booth not respecting the Organizing Committee's requirements.

#### Use of venues

The venues shall not be used for any illegal or immoral purpose and the Organizing Committee reserves the right to remove all material that in their sole opinion may be considered offensive or obscene. It is forbidden to have any cash transaction at the venues.

All goods and property brought into the venues are brought in at the owner's risk.

#### Loss or damage to Exhibitor's property

The Organizing Committee shall have no liability for the damage, theft or loss of any Exhibitor's property in any circumstances. The Exhibitor is responsible for taking out adequate insurance.

#### Loss or damage caused by the Exhibitor

The Exhibitor will indemnify the Organizing Committee against: all actions, claims, suits, costs, expenses, demands (whether in respect of damage to property, personal injury or otherwise and including all legal costs and other expenses suffered or incurred by the Organizing Committee) which any person may bring or claim arising from and out of the use of the Venues by the Exhibitor, its employees, servants, contractors and invitees; loss and damage to the Venues and to any property therein arising out of the use of the Venues by the Exhibitor, its employees, servants, contractors or invitees and in particular but without prejudice to the generality, of the foregoing caused by the use or misuse of water, gas or electricity.

#### Personal accidents

The Exhibitor must occupy and use the Venues and the space there allocated to it at its own risk and neither the owner nor the Organizing Committee accept any liability for any accident, damage or injuries suffered at the Venues by the Exhibitor, its servants, agents, contractors, invitees, member of the public, or any person whatsoever.

#### Cancellation of participation

Cancellation fees will be charged for withdrawal, for whatever reason from the EHEF 2017 as of the date of receipt of written notice of withdrawal, Cancellation rates are as follows:

- 50 percent of the full EHEF 2017 exhibitor fee will be charged if the cancellation is made before the 1" April 2017.
- 100 percent of the full EHEF 2017 exhibitor fee will be charged if the cancellation is made on or after the 1<sup>st</sup> April 2017.

### Cancellation of EHEF 2017

The Organizing Committee reserves the right to postpone, curtail, move, extend or abandon EHEF 2017, or to move Exhibitors, or to close individual or all sections of the Exhibition temporarily or permanently, if unforescen events so require. Should it be necessary to postpone, curtail, move or extend or abandon the EHEF 2017, the Exhibitor shall not be entitled to withdraw from the contract nor to claim indemnity.

#### Disclaimer

The Organizing Committee accepts no liability for loss or damage suffered by the Exhibitor and caused by:

- The failure of any service or amenities which the Organizing Committee is responsible for providing;
- The failure of any service or amenities to be provided by the Fair contractors;

Cancellation or suspension of the Fair due to force majeure, including but not limited to
earthquake, typhoon, adverse weather, strikes, fires, floods, terrorism, pandemics, acts of god or
any natural disaster, or by reason beyond the Organizing Committee's control.

In such circumstances, and where appropriate, the Organizing Committee may pay any exhibition costs that were unavoidable from the fees paid by the Exhibitors. The balance of the fees paid by the Exhibitors would be refunded less the unavoidable costs that have been paid by the Organizing Committee. The balance would be divided equally between all Exhibitors. Exhibitors will be responsible for any cancellation charges on flights, accommodation and any other costs that they may incur.

There are circumstances where acts of god, natural disasters, tension or incidents will raise a safety threat but not be sufficient to cancel EHEF 2017. In such circumstances, some individuals or institutions may feel unwilling to visit the country and therefore decide to withdraw from the event. The Organizing Committee would make every effort to facilitate this with the minimum penalty to the Institution. In the event of such a withdrawal, normal cancellation charges will apply, except to the extent that the Organizing Committee is able to reduce the charges without Jeopardising the financial viability of the event.

The Organizing Committee accepts no responsibility whatsoever for licensing matters, customs duties, import charges, taxes, and the delivery of visas, hotel rooms or Exhibitors' travel arrangements.

#### Termination of participation

The Organizing Committee is entitled to terminate without notice the participation of an Exhibitor if:

- The Exhibitor or its designated representative commits any breach of, or fails to observe, any of
  the conditions or regulations set out in these terms and conditions;
- The Organizing Committee, at its sole and absolute discretion, decides that participation shall be terminated;
- The Exhibitor has a receiver appointed over all or part of its assets, enters into liquidation, or commits an act of bankruptcy, whether compulsorily or voluntarily
- \* The Exhibitor fails to pay any sum due

# Annex 2 Application Guidelines: European Higher Education Fair 2017 Japan (EHEF 2017)

#### I. Exhibitor eligibility

In order to be eligible to exhibit at the EHEF 2017, the institutions must:

- -Be an education institution with their headquarters in one of the Erasmus+ Programme Countries (EU, EEA, Turkey, FYROM), OR
- -Be an official representative/agent in Japan of an education institution with their headquarters in one of the Erasmus+ Programme Countries (EU, EEA, Turkey, FYROM), OR
- -Be an official representative of an embassy in Japan which represents education institutions with their headquarters in one of the Erasmus+ Programme Countries (EU, EEA, Turkey, FYROM), or is a member of the European Free Trade Association.
- -Be an official cultural and/or language institute or accredited national education agency of one of the Erasmus+ Programme Countries (EU, EEA, Turkey, FYROM)

#### II. Booth allocation

Booths are allocated to eligible education institutions on a first-come, first-served basis, with, in principle, one place guaranteed per country. If after the initial deadline certain places have not been taken up, these will be offered in the first instance to institutions applying through our official co-organizers (Campus France, DAAD), and to EU programmes, prior to being offered to institutions from other countries in the order that applications were received. Should places still be available these will be made available to institutions in all eligible countries on a first coine first served basis.

Due to a limited number of booths, priority for participation in the Kyoto event will be given to institutions whose staff will be travelling to Japan especially for the event (i.e. with no permanent representative based in Japan). Institutions will only be considered on receipt of a complete, signed application form (pdf scan by email), along with a completed institution Information Sheet by small. The Organizing Committee reserves the right to select institutions to take part in the fair based on the exhibitor selection criteria, as described above. French and German institutions will firstly register participation with Campus France Japan and DAAD Germany.

#### III. Payment of fees

Once participating institutions have been selected by the Organizing Committee a request for payment of participation fees will be sent by Campus France Japan. Participation is only confirmed when this fee is received.

#### V. Further points of importance

- It is NOT possible to participate only in the Kansai (Kyoto) fair.

- Booth Interpreters will not be provided at either the Tokyo or Kansai (Kyoto) fair.
- Exhibitors may bring up to four staff, BUT there will only be space for two staff to be behind the booth at any one time.
